Linda Corbett made a motion to accept the nomination and Don Hann seconded the nomination. Ballots were counted by Leslie Johnson and Wendy Anaya. Liza Merrill was re-elected.

PCJSL Code of Conduct:

Ted Schmidt discussed the Code of Conduct and gave a synopsis of how the code of conduct works and how it is has been received by the PCJSL parents and players.
