



ASA INTERCLUB PLAYER LOAN FORM

The completion of this form is required for any ASA registered player wishing to participate with an ASA club other than the club of which the player is registered. Participation includes but is not limited to games, scrimmages, tryouts, practices, placement events, clinics, and camps. The signatures of the parent/guardian, the team official of registered team and team official of "Team Loaned From" are ***always*** required.

11U and OLDER

July 1st to April 28th the signature of the loaning club President or DOC is required for player participation with another club **in addition** to the signature of the parent/guardian and the team officials.

April 29th – June 30th the signature of the loaning club President or DOC is not required unless otherwise specified by loaning club. During this period, this form is only required for game participation when player pass is needed, and the signatures of the parents and team officials of both clubs are required.

10U and YOUNGER

July 1st to April 21st the signature of the loaning club President or DOC is required for player participation with another club in addition to the signature of the parent/guardian and the team officials.

April 22nd – June 30th the signature of the loaning club President or DOC is not required unless otherwise specified by loaning club. During this period, this form is only required for game participation when player pass is needed, and the signatures of the parents and team officials of both clubs are required.

ASA Policy 5171:

A registered player may not participate in any event such as, but not limited to, games, placement events, practices, clinics, camps, or tryouts of another club without the home club's permission prior to April 29th for 11U & older and April 22nd for 10U & younger. ASA will not recognize any registrations, registration contracts, registration fees and/or deposits received between May 1 and June 15. A player shall be released with a full refund upon request during this time period.

Any infraction of this policy may be brought forth to ASA, in writing, by affected party(ies) which is defined as an official complaint. The complaint will be heard by the Discipline and Appeals committee within 30 days after officially receiving the written complaint. If person(s) are determined guilty through a proper hearing, suspension could range from a minimum of 6 months to a maximum of 2 years. If repeated offenses occur for particular person(s), suspensions could be a minimum of 2 years to maximum of 10 years.
